- 1. I, Shyamprasad D. Limaye, a Company Secretary in practice, has been appointed by the Board of Directors of Maharashtra Scooters Limited ("The Company") as a scrutinizer for the purpose of Scrutinizing the evoting process along with instapoll, and ascertaining the requisite majority on voting carried out as per the provisions of Section 108 of the Companies Act, 2013, read with Rule 20 (4) (ix) of the Companies (Management and Administration) Rules, 2014 as amended, on the Resolutions contained in the notice (hereinafter referred to as "the resolutions") of the 41st Annual General Meeting (AGM) of the members of the Company, held on Monday 25th July, 2016 at 12.15 P.M at Registered office of the Company at C/o. - 3. The management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and Rules relating to voting through electronic means and instapoll on the resolutions contained in the Notice to the 41st Annual General Meeting (AGM) of the members of the Company. My responsibility as a scrutinizer for the remote e-voting process and instapoll is restricted to make a Scrutinizer's report of the votes, cast "in favour" or "against" the resolutions and "invalid" and "abstained" votes, based on the reports generated from the e-voting process system provided by Karvy Computershare Private Limited, the authorized agency engaged by the Company, to provide remote e-voting facilities and instapoll.

 - i. The remote e-voting period remained open from Friday 22nd July, 2016 (9:00 A.M) to Sunday 24th July, 2016 (5:00 P.M).



- ii. The members who were on record of the Company as on the "cut-off date i.e. Monday, 18th July, 2016, (End of Day) were entitled to vote on the resolutions as set out in the notice of the 41st Annual General Meeting (AGM) of the Company.
- iii. The votes cast via remote e-voting were blocked on Sunday 24th July, 2016 immediately after completion of voting hours in the presence of 2 witnesses, Mr. Neelkanth G. Limaye and Mr. Bhushan M. Lunawat who are not in the employment of the Company.
- iv. The instapoll was again provided at the 41st Annual General Meeting on Monday 25th July, 2016 for those members who attended the meeting but not voted through remote e-voting facility, and such e-voting was unblocked after completion of such voting.
- v.
