हैदराबादपासून सुमारे ५० किमी अंतरावर असलेल्या चेंबेराजवळ हा अपघात झाला. अपघात इतका भीषण होता की बसच्या एका बाजूचा अक्षरशः चेंदामेंदा झाला. अपघातात दोन्ही वाहनांचे चालक मृत्युमुखी पडले, असे सायबराबादचे पोलिस आयुक्त अविनाश मोहंती यांनी सांगितले. अपघातामागचे नेमके कारण चौकशीनंतर कळेल, असेही ते म्हणाले. डंपरमधून खडी वाहून नेली जात होती. अपघातानंतर ती

बसवर पडली. त्यामुळे बसमधील प्रवासी आतच अडकले. ही बस रंगारेड्डी जिल्ह्यातील तंदूर येथून हैदराबादकडे निघाली होती.

केल्यानंतर सांगितले. मुख्यमंत्री ए. रेवंत रेड्डी यांनी अपघाताबाबत मंत्री प्रभाकर आणि वरिष्ठ अधिकाऱ्यांशी दूरध्वनीवरून चर्चा केली. तसेच, जखमींवर तातडीने आणि योग्य उपचार करण्याचे निर्देश केले. या घटनेच्या चौकशीचे आदेश देण्यात आले असल्याचेही ते म्हणाले. राज्य सरकार मृतांच्या नातेवाईकांना प्रत्येकी ५ लाख आणि जखमींना प्रत्येकी दोन लाखांची मदत केली जाईल, असेही ते म्हणाले.
